In addition, provide: (1) fiscal year end financial statements (whether internal, audited, reviewed or compiled) for each full calendar year preceding the date of separation; (2) monthly financial statements (profit, loss and balance sheets) for each month preceding the date of separation if the separation occurred in a year for which a tax return had not yet been filed; and (3) a monthly financial statement for the month preceding, the month of, and the month following the date of separation.						
[]	Personal Financial Statements. All personal financial statements provided to any financial institution or other entity or person in the last three (3) calendar years preceding the date of separation through the date of service of the certification of initial disclosures.						
[]	Appraisals/Valuations. All opinions of value or appraisals of any real or personal property acquired by the parties during the marriage and owned on the date of separation.						
[]	Bills of Sale. All bills of sale or other documentation of real or personal property sold or transferred in the 12 months preceding the date of separation or after the date of separation through the date of service of the certification of initial disclosures.
